#### HOSTEL REGULATION POLICY

## 1. INTRODUCTION

This policy document outlines the regulations and rules that govern the functioning of SDGI Hostels. All students residing in hostels are bound to adhere to these rules.

## 2. ADMISSION TO HOSTEL

- New Admissions: Admission information and hostel forms are provided along with the Institute admission form. Full hostel fees must be deposited before room occupation.
- **Returning Students**: 2nd year onwards students must reapply and pay full hostel fees for two semesters. Readmission is based on discipline and attendance.

#### 3. ACCOMMODATION & FEES

- **Room Types**: Single and double seater, with/without AC and attached toilets.
- Furnishings: Each room includes bed, table, chair, almirah, fan, and lighting.
- Fee Structure:

- Cooler Charges: ₹1000 per 3 months
- Extensions: Fee must be paid 7 days in advance or a new package will be issued.

## 4. ROOM UPKEEP

- Students must maintain cleanliness and report damage. Damages are chargeable.
- Wall writing, posters, and defacement are strictly prohibited.

## **5. LEAVE & OUTPASS**

- Outpasses are allowed for visits to local guardians with parent approval.
- **Timings**: Issued between 9:00 AM 5:30 PM.
- **Procedure**: Outpasses require proper logbook entries and are to be shown at gates.

## 6. ATTENDANCE

- Daily attendance at 9:00 PM; hostels locked by 10:00 PM.
- Surprise checks and reports on defaulters are conducted by hostel staff.

## 7. CLASS ATTENDANCE

 Hostel staff will monitor hostellers present in hostels during class hours (9 AM - 5 PM). Repeat offenders will lose hostel accommodation.

## 9. GUEST POLICY

- Permitted only on weekends/holidays.
- Allowed in reception area only.
- Day scholars not permitted without permission.
- Visitors allowed: parents and siblings only. ₹500/day if overnight stay is permitted.

## 10. GIRLS HOSTEL VISIT RULES

- Female visitors must get written permission.
- Meetings outside hostels or at cafeteria.
- Maintenance staff must be escorted.

## 11. MEDICAL AID

• Hostel In-Charge will arrange medical assistance and inform guardians when necessary.

## 12. MESS RULES

- Kitchen/store entry prohibited.
- Misbehaviour with staff will attract disciplinary action.
- Food must not be taken outside dining hall.
- No alcohol/smoking.
- Dress code in mess must be decent.

## 14. CODE OF CONDUCT

- ID cards mandatory.
- Prohibited: alcohol, drugs, vandalism, gambling, loud behavior, theft.
- Expulsion for drug use.

## 15. SECURITY

- Students must secure personal belongings.
- Room changes not allowed without permission.
- Curfew is 10:00 PM. Missing roommates must be reported immediately.

## 16. RAGGING POLICY

• Zero tolerance. Legal and academic consequences include FIR filing, Suspension/expulsion, fine up to ₹25,000.

## 17. WITHDRAWAL & EXPULSION

- Written request with parental consent.
- No refund after 3 months.
- Expulsion possible for serious violations.

## 18. ADDITIONAL RULES

• No inter-hostel visits between male/female students.

- Unauthorized appliances attract a ₹1000 fine.
- Celebrations need prior approval and must end by 11 PM.
- No meetings without permission.
- Silence and order required at all times.

## 19. DISCIPLINE COMMITTEE

• Governed by Institute Disciplinary Committee.

• **Breakfast**: 8:00 AM to 9:15 AM
